The Last Will and Testament of Simon Mawe of Rendlesham in the County of Suff gent made the last day of September one thousand six hundred and four as followethe. First I bequeath my soule into the hands of Almighty God my Creator hoping of eternal life and salvation by the grace and passion of our blessed Lord and Saviour Christ Jesus and my body to be buried in the chancel of the Parish Church of Rendlesham. And ... ... all ... goods and chattels and lande, tenaments and hereditaments wherewith it hath pleased god to blesse me ... of in manner and forme following. First I give and bequeath unto every one of the children of Francis Burwell of Sutton in the County of Suffolk gentleman and Jane his wife being my grandchildren fifty pounda peece of lawful English money. Also to every one of the children of William *Downing* of Spexhall in the sayers County of Suff gent and Anna his wife who was my daughter being three in number fortie pounds a peece of lawful English monie uppon condition that the sayers William Downing ..... to be .... myne Executors one .... or .....ing obligatory wherein the sayers Simon Mawe stand bounde to the sayers William Downing for the payment of one hundred pounds to and amongst for the child or children of the .... of the said Anna to be on ... begotton by the sayers William Downing and shall happen to be living at the time of the death of me the sayers Simon which hundred pounds so to be paid within one year next after my death or to the like ... ... and by the same working obligatory ..... in the condition thereof and if the said William Downing shall not decline the sayers wryting obligatory within six months after reasonable demand made by my Executors or one of them or by any of their assignes. Item then I will this my ..... and bequeath to the children of the sayers William Downing to be ..... also I will and bequeath unto valentine Smithe of Chiswick in the County of Midd gent and Kimborough his wife being my grandchildren three hundred pounds of lawful English money and to all the five of the children of the said William Smithe begotton of the same and Kimborough to any of them forty pounds a peece of lawful English money. Also to the daughter of Ralph Conyers gent and Mary his wife being my grandchild forty pounds of lawful English money. Also to Kimborowe Mawe the daughter of George Mawe if she do live until the age of eighteen years then I give her one hundred pounds of lawful English money and not before Also to Kimboroughe Mawe the daughter of Thomas Mawe three hundred pounds of lawful english money Also I will that all my lands tenements and ... in the countie of Lincoln and York shall be and remayne unto Charles Mawe my sonne and the heir of his body lawfully begotten And if the sayers Charles shall happen to sell the sayers land and tenements that then I will that he shall sell them to Thomas Mawe or Leonard Mawe my sonnes, they or each of them giving to sayers Charles the full value for them. Also I give will and bequeath unto

the sayers Charles and unto the heir male of his sonne lawfully begotten all those my lands, tenements in Snape in the countie of Suff. Also I will that all my mannor lands, tenaments and hereditaments to the five and to the free and ... and all my lease and lease lands in Eyke, Broomswell, Sutton .... Melton, Bredfield, *Hapleton*, Woodbridge, *Pettistree* and *Dallingham* in the county of Suff shall be and remaine to .... and in such manner and form as be expressed .... the land declared in an Indenture ... like made between me the sayers Simon Mawe on the first part and sqr Henry Manner Knight and other on the second part and George Mawe gent and other on the third part bearinge date the ... and .... Day of August in the Seventh year of his Maj reign over England .... Ireland and over Scotland the three and... also I will bequeath all my chattels and household stuffe shall be .... And the value thereof to be .... to Charles Mawe my sonne at the day of his marriage (if he live to be married) and I do ordain and make my Executors of this my late will and testament Thomas Mawe, Leonard Mawe and Charles Maw my sonnes. Witnessed Francis Burwell, Robert Mann, Thomas Willett with others.
